

## CDL TEST WAIVER FOR MILITARY MEMBERS

The Troops to Trucks military skills test waiver program allows a qualified military member to apply for a Commercial Driver's License (CDL) without skills testing. CDL knowledge (written) test(s) may be waived for certain military occupations through the Even Exchange program. **These programs do not waive school bus endorsement requirements.** Licensed military members and those employed within the past 12 months in a military position requiring the operation of a military motor vehicle equivalent to a Commercial Motor Vehicle (CMV) may apply for the above programs.
